

**THE “B-105 COUNTRY SPRING BREAK SONG OF THE DAY –  
LUKE BRYAN TRIP” CONTEST**  
**OFFICIAL RULES**

1. **Dates/Eligibility.** The “B-105 Country Spring Break Song of the Day – Luke Bryan Trip” Contest (the “Contest”) begins Monday, March 20, 2017 and ends on Thursday, March 23, 2017. WUBE (the “Station”) may change the dates and/or terms of the Contest, including canceling the Contest, without prior notice. Any material changes will be broadcast on the Station and posted online on a page at [www.b105.com](http://www.b105.com) (the “Site”). The Contest is open to all legal residents of Ohio, Kentucky or Indiana, eighteen (18) years of age or older at the time of entry. There is no purchase necessary to enter or win. A purchase will not increase a contestant’s chance of winning. The Contest is void where prohibited by law. Employees or agents of the Station, Hubbard Broadcasting, Inc., Capitol Nashville, any entity associated with the sponsorship or administration of the Contest (collectively, the “Sponsors”) or any other television or radio station that transmits a signal for reception in Ohio, Kentucky or Indiana, as well as members of the same household of any such employee or agent, may not participate. No more than one (1) winner per household. Contestants can only win once per day. Previous winners of contests conducted by the Station must comply with the following time limit before attempting to enter the Contest: Contestants may only win one prize per person valued at or above \$10,000 every six months unless specified otherwise. Each time limit is measured from the date the winner won their prize in the prior contest.

2. **How to Enter.** To participate in the contest, contestants must listen to WUBE every weekday during the contest period at approximately 9:09 a.m. for the announcement of that day’s “B-105 Country Spring Break Song of the Day” (the “Song”). Whenever this Song is played between 9:09 a.m. and 9:00 p.m. that day, the first nine callers through to the station’s contest line ((513) 749-2105) are entered into grand prize drawing.

3. **Selection of Winner.**

- a. Contestants must listen to win pursuant to section 2 of these official rules. Grand Prize qualifiers will be notified on-air.

4. **Prizes.**

- a. There are no qualifying prizes awarded in this contest.
- b. All eligible qualifiers will be in random drawing for grand prize. Grand prize is a Trip for two (2) to see Luke Bryan in concert in San Diego, CA (arv = \$2,500) includes:
  1. 2 nights hotel accommodations (10/26 & 10/27/17);
  2. 2 tickets to Luke Bryan concert on 10/27/17 at Sleep Train Ampitheatre;
  3. Roundtrip airfare for two.
- c. Grand prize drawing will occur on Friday, March 24, 2017 at approximately 9:00 a.m. Grand prize winner will be notified by telephone. In the event that grand prize winner cannot be reached within 48 hours, a new grand prize drawing will take place.

d. Winners will be required to complete an IRS Form W-9 and will receive an IRS Form 1099-Misc.

5. **Conditions/Restrictions.** In exchange for the right to participate in the Contest, each contestant agrees to release and indemnify each of the Sponsors, and the officers, directors, agents, parent companies, subsidiaries and employees of each of the Sponsors, for, from and against any and all claims, demands and/or causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the contestant's participation in the Contest and, if the contestant is the winner of the prize, the use of their prize. Entry into the Contest constitutes permission for each Sponsor and its respective designees to use the contestant's name, likeness, portrait, voice and/or biographical material for an unlimited period of time in order to advertise, promote or publicize the Sponsor and/or the products and services of any of its designees. Winner will be required to produce identification satisfactory to the Station and sign an affidavit of eligibility and release (including a publicity release) as prepared by the Station. Anyone using fraudulent means to participate in and/or win the Contest will be subject to disqualification.
